This training workshop is designed for therapists who are experienced in working with children and have completed EMDR level 1 or EMDR part 1 training before 30 June 2012. The training might also be of interests to therapists who work with learning disabled people, as modifications of the EMDR protocol for children could be useful for them.

The training day has a clinical focus. Emphasis is placed on working with children within the social contexts of the child. Differences in the use of EMDR for adults and for children will be highlighted. Trainees will learn how to modify the standard EMDR protocol for children from age 2 onward for the variety of clinical presentations common in childhood. Lectures, videos and case descriptions will demonstrate the essential learning points. Trainees will be made aware of difficulties that can arise when treating children with EMDR.

About the presenter:

Dr Kamala-Maria Mueller trained in medicine and started her career in psychiatry in 1983. Since 2000 she has been employed as consultant child and adolescent psychiatrist in Nottingham. She started her training in EMDR in 1994 and is an EMDR-Europe accredited consultant, facilitator and Child and Adolescent Trainer. She offers individual EMDR sessions, EMDR supervision and supervision groups. She gave lectures and workshop on EMDR at European conferences. Her special interest lies in resource development using bilateral stimulation and the use of EMDR for the wide variety of clinical issues.
